ORDER

Kerala Water Authority (KWA) has been facilitating a Comprehensive Group Health Insurance Scheme for its employees since 2014-15. The existing Group Health Insurance Policy for the employees of KWA was renewed with M/s. United

India Insurance Company Ltd., Trichy, effective from 16.04.2025 (GHIS Policy No.: 0906002825P103331092).

As per the policy conditions:

- a) The total annual premium shall be paid intwo equal installments.
- b) The **first installment** shall be released at policy inception, based on the available insured members.
- c) The **second installment** shall be paid at the end of six months from the inception date.

Accordingly, KWA remitted an amount of ₹12,47,80,752/- (Rupees Twelve Crore Forty Seven Lakh Eighty Thousand Seven Hundred and Fifty-Two only) towards the first installment premium in respect of 7600 employees and their dependents, as per paper (1) read above.

During the first half of the current policy period, 169 employees (and their dependents) were removed due to relieving /LWA/VRS & Deputation and 116 employees (and their dependents) were newly included due to joining of new candidates, as detailed below:
