ORDER

As per the read cited first, a proposal had been submitted to Government for converting certain outdated posts in Kerala Water Authority into functionally relevant posts as part of Knowledge Administration. In accordance with the Government Order read as second above, as a first phase, 34 posts of Meter Readers have been created by converting 39 posts of Office Attendants in Kerala Water Authority. Accordingly, sanction is hereby accorded to abolish 39 posts of Office Attendants and to allot 34 posts of Meter Readers to various offices in Kerala Water Authority.

Vide Ref III, allotment of 34 Meter Readers advised by Kerala Public Service Commission to respective offices is permitted on condition that no transfer is effected to existing Meter readers.


