In exercise of the powers conferred by sub-section (1) of Section 55 of the Kerala State Housing Board Act, 1971 (Act 19 of 1971) read with section 54 thereof the Kerala State Housing Board hereby announce for general information that the Board at its meeting held on 23-3-1993 has

approved the project report for the implementation of a Housing Complex under Rajiv One Million Housing Scheme in Kattappana Panchayat in Udumpanchola Taluk, Idukki District envisaging provision for construction of 28 Nos. of individual houses as 1st stage at a project cost of Rs. 9.98 lakhs per item No. 5-7. Accordingly sanction has been accorded for the implementation of the project at a cost of Rs. 9.98 lakhs.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Under sub-section (1) of section 55 of the Kerala State Housing Board Act, 1971 (Act 19 of 1971) read with section 54 thereof the Kerala State Housing Board has to notify Boards sanction to any housing or improvement scheme. Accordingly Boards sanction for the Housing Complex at Kattappana Panchayat for which proceedings of the Board No. P3-2973/93/1097 dated 4-6-1993 has to be notified.

The notification is intended to achieve the above purpose.

In exercise of the powers conferred by sub-section (i) of section 31 of the Kerala Water Supply and Sewerage Act, 1986 (14 of 1986) and with the formal approval of the Government of Kerala conveyed in GO Ms No. 45/93/LAD dated March 1st, 1993 and Proceedings No. KWA/HO/AO F/16/67/93 dated 31-5-1993 and in supersession of all the existing Orders in this regard, the Kerala Water Authority hereby refix the cost of water to be supplied by the said Authority in its service areas to the following consumers classes, as shown below, with effect from June 1st, 1993, and subsequently for the automatic revision of water tariff by 15% every year from 1st April 1994 onwards.

Consumption per month	Rate
(a) DOMESTIC CONNECTIONS	
1. Upto 10,000 litres	Rs. 15 p. m. minimum charges
2. 10,000 to 30,000 litres	Rs. 15.00 plus Rs 2.00 per 1000 litres in excess of 10,000 litres.
3. 30,000 to 50,000 litres	Rs. 55.00 plus Rs. 3.00 per 1000 litres in excess of 30,000 litres.
4. Above 50,000 litres	Rs. 115.00 plus Rs. 4.00 per 1000 litres in excess of 50,000 litres.
(b) Non-Domestic CONNECTIONS	
1. Upto 50,000 litres	Rs. 4.00 per 1,000 litres with Rs. 50.00 minimum charges.
2. Above 50,000 litres	Rs. 200.00 plus Rs. 6.00 per 1,000 litres in excess of 50,000 litres.
(c) INDUSTRIAL CONNECTIONS	
For entire consumption	Rs. 6.00 per 1,000 litres with Rs. 100.00 minimum charges.

Automatic revision of water tariff by 15% every year from 1st April 1994 onwards.
