

ORDER

As per Read (1), an NRWM Unit was constituted in Kochi to detect water theft and prevent unauthorized usage. Vide Read (2), the NRWM Unit, Kochi was authorized to detect, report, and take action on all matters related to water theft, meter tampering, manipulation of readings, illegal connections etc in schemes under Central Region, Kochi.

As per the orders cited 3rd above, Anti-Theft Squad (ATS) has been formed

under the three Regional Offices headed by respective Deputy Chief Engineers. Accordingly, Kochi, NRWM Unit has been abolished. It is directed that all files, registers, equipment, furniture, computers, and other assets of the NRWM Unit shall be taken over by the Deputy Chief Engineer, Central Region, Kochi.


Henceforth, all revenue, disconnection, and theft cases in which NRWMU, Kochi is the respondent shall be handled by the Deputy Chief Engineer in charge of ATS. The list of such cases shall be communicated to the Chief Law Officer for information and necessary follow-up.

The posts under the NRWM Unit, Kochi are shifted as detailed below.

1. The post of Assistant Engineer with incumbent Smt. Resmi K.R (G12611), is hereby shifted and attached to PPDIU Kochi for IURWTS Work.
2. The post of Driver with incumbent Sri. Sageer K M (G13782), is hereby shifted and attached to the Office of the Chief Engineer, Central Region, Kochi.
3. The post of Fitter with incumbent Sri. Biju C S (G44599) is hereby shifted and attached to PH Section, Angamaly under PH Sub Division Angamaly.

Vide read (4) & (5), the orders issued by the Central Region, Kochi is hereby cancelled.

The Controlling Officers concerned are directed to relieve the incumbents in the shifted posts immediately. The sanctioned strength of the respective offices shall be revised accordingly by the Heads of Office, and the Administrative Wing in the Head Office shall verify the same in due course.
